Survivors of sexual assault should obtain medical care as soon as possible following an assault. The NWA Center for Sexual Assault offers free forensic medical exams in a compassionate, non-hospital setting. Forensic medical exams gather DNA and other evidence from the survivor's body and can be performed any time within 96 hours of a rape or sexual assault. They provide services to the Northwest Arkansas area (Benton, Madison, and Washington counties) and they utilize only trained Sexual Assault Nurse Examiners. In addition to collecting evidence, their nurses offer preventative antibiotics for sexually transmitted infections. To protect evidence, avoid bathing, brushing teeth, or washing clothing or sheets. If you change clothes, place the clothing along with sheets or other items in a paper bag and take them to the hospital with you. A forensic exam is provided at no cost and does not require filing a police report. In addition to physical evidence, keep phone records, texts, emails, and gifts.
